OFFICE MEMORANDUM

Sub: Delegation of power to grant of Medical Advance under CS(Medical attendance) Rules-Instruction thereon.

The existing procedure on delegation of powers to grant of Medical advance to the Govt. employees under the CS(MA) Rules laid down that the sanction of Medical advance to the Govt. servants beyond the limit of Rs. 1000/- should be subject to the prior concurrence of Finance Deptt. in terms of GOI's OM No. S.11016/1/92-CCHS(P) dtd 29th Oct'99. The power to sanction Medical Advance to the extent of Rs. 1000/- had already been decentralised to the HoDs/HOOs under the aforesaid orders of GOI. The GOI, further, delegated the power to their administrative Ministries/Department for grant of MA to their employees beyond the limit of Rs. 1000/- Vide OM No. S.14025/7/94-MS dtd. 15th May'99 subject to such terms and conditions specified therein and as incorporated in the CS(MA) Rules, 1944. In the light of the above orders of GOI, it has been decided to re-delegate the aforesaid powers to various authorities under this Govt. with some restriction Accordingly the following authorities under this Govt. is authorised to sanction medical advance under the CS(MA) Rules, 1944 to the Govt. employees under their control upto the specified. limits restricted against each below:-

The exercise of the aforesaid powers should be subject to fulfilment of all other terms and conditions of grant of advance as laid down in the rules and orders of GOI under the CS(MA) Rules amended from time to time. Also subject to availability of fund in the respective sanctioned budget grants and adjustment of advance within 60 days of discharge.

The Medical Advance cases beyond the limit of Rs. 10,000/- on fulfilment of the terms and conditions enuciate in the rules and orders under the CS(MA) Rules, should be submitted to the Finance Deptt. for concurrence before sanction.

The other guidelines/Instruction stipulated for grant of Medical Advance issued by Finance Deptt. from time to time shall continue to be followed and will remain unaltered.
